



## Spring Members Draw Competition

### Overview

BRC Members who enter the racecourse on the Saturdays of Ladbrokes Spring Racing Carnival before the competition closing time will go in the draw for their chance to win \$250 F&B credit.

By participating in the **Spring Members Draw Competition** participants guarantee that he/she/they has the authority to accept and unconditionally accept the below terms and conditions.

### How to Enter

To be eligible, participants must attend at least one day of Ladbrokes Spring Racing Carnival (eligible dates and times listed below) and have their Membership Card scanned to confirm their attendance.

The following persons are ineligible to enter the Competition:

- a) employees, directors, officers, management, contractors and other representatives of the Promoters, and organisations involved in, or sponsoring, or conducting the Competition;
- b) individuals (including judges) involved in, or sponsoring, or conducting the Competition; and
- c) immediate family members and households of any such persons.
