



How to Enter;

- 1. To be eligible participants must be 18 years of age or older and purchase any beer product at Eagle Farm Racecourse on Blokes Day out 23rd March 2019.
- 2. Eligible participants will be issued with a promotional entry form at the time of purchase, and will be required to complete their details in full and place it in the Barrel at any of the 3 entry points. (ie. Entry points are as follows; Members Reserve, Public Lawn and Stradbroke Plaza near the Utes displayed). Additionally Brisbane Racing Club Promotional staff may assist with the completion and posting of the entry form to the entry barrel on the participants behalf).
- 3. The Brisbane Racing Club Board, Management Committee, Management, Staff and their families are ineligible to enter into the promotion.
